#### AMENDMENT TO DEPED ORDER NO. 030, S. 2020

(Amendment to DepEd Order No. 007, s. 2020, School Calendar and Activities for School Year 2020-2021)

To: Undersecretaries Assistant Secretaries Minister, Basic, Higher and Technical Education, BARMM Bureau and Service Directors Regional Directors Schools Division Superintendents Public and Private Elementary and Secondary School Heads All Others Concerned

- Based on the continuous monitoring by the Department of Education (DepEd) of the implementation of the Basic Education-Learning Continuity Plan (BE-LCP) through the results of formative assessments, portfolio of learning outputs, and other activities given to learners, there has been an identified need to address learning gaps in order to meet the required essential learning competencies. These learning gaps are attributable to reduced academic opportunities at home and substantial loss of live contact with teachers.
- To address the learning gaps and to give additional pedagogical time to teachers for the different learning delivery modalities, the Department issues this Amendment to DepEd Order (DO) No. 030, s. 2020.
- 3. Paragraphs 3 and 4 of DO No. 030, s. 2020 are amended as follows:
  - From March 1 to March 12, 2021, schools shall conduct 3. intervention and remediation activities based on the unique needs of the learners as determined through the results of the different forms of assessments administered for the past two quarters. These intervention and remediation activities shall be indicated in the two-week home learning plan to be prepared by the teachers, with the assistance of the assigned learning support aides (LSAs) as applicable.
  - From March 15 to March 19, 2021, teachers shall attend 4.1 a professional development program through an In-Service Training (INSET) organized by the school or other relevant units of DepEd.
  - The schedule for the succeeding quarters shall be adjusted as follows:
    - 4.2.1. Quarter 3 shall be from March 22, 2021 to May 15,

# 4.2.2. Quarter 4 shall be from May 17, 2021 to July 10, 2021

- 4.3 The additional two-week period shall be compensated by a similar adjustment in the school break between SY 2020-21 and SY 2021-2022.
- 4. This policy shall be implemented in all public elementary and secondary schools nationwide for SY 2020-2021. Private schools, technical and vocational institutions, and higher education institutions, including state and local universities and colleges offering the K to 12 Basic Education Program are encouraged to implement these guidelines according to their philosophy, vision, and mission.
